Subject: Support – Expansion of Medi-Cal to Undocumented Young Adults, FY 2019-20 State Budget

Dear Chairwoman Reyes,

On behalf of the members of the California Association of Public Hospitals and Health Systems and the millions of patients they serve, I am writing to voice our support for the budget proposal that would expand Medi-Cal to all income-eligible young adults, up to age 26, regardless of immigration status. Immigration status remains a barrier to coverage and access for some Californians; this proposal would help close a critical gap for those who remain without coverage. We also support the legislative proposals that would extend coverage to an even larger number of uninsured.

California's 21 public health care systems are the core of the state's health care safety net, delivering high-quality care to all who need it, regardless of ability to pay or insurance status. Most patients seen in public health care systems are either Medi-Cal beneficiaries or remain uninsured. Public health care systems provide services to more than 2.85 million Californians annually, provide nearly 30 and 40 percent of hospital care to the state's Medi-Cal and uninsured populations, respectively, and provide over 10 million outpatient visits each year. Public health care systems also operate half of the state's top-level trauma and burn centers, and train half of all physicians in the state.

As safety-net providers whose mission is to serve all members of our community, public health care systems understand firsthand the importance that coverage can have on health, access to care, and financial stability for low-income populations. Public health care systems have played a critical role in numerous efforts to expand services or coverage to the uninsured, including the implementation of the Low Income Health Program, the recent effort to expand coverage to all children; and many local efforts that expand services, including access to a regular primary care for uninsured and low-income individuals.

Expanding coverage to this population would build on California's impressive health reform implementation efforts, bring our state one step closer to achieving universal coverage, and support for more comprehensive care delivery. The budget proposal would provide security for

patients, and allow providers to focus on connecting patients with the right care in the most appropriate setting, supporting better care coordination and improved health.

For these reasons, we support the budget proposal to expand Medi-Cal to undocumented young adults. We would be pleased to further discuss our position with you and answer any questions you may have.
