Dear Public Health Care System Leaders,

As the federal government shutdown enters its fourth week with no resolution in sight, uncertainty in Washington continues. While not the focus of the strife in Washington, DC, we must collectively continue to remind our congressional members to retroactively reverse the DSH payment reductions and extend the Medicare telehealth flexibilities to protect stability for our systems and patients. CAPH continues to remind our congressional delegation of the importance of not losing sight of this when a Continuing Resolution (CR) is passed. Thanks to each of you for also ensuring our Members of Congress hear this message.

While the debate in Congress remains far from home, its impacts are increasingly local. The ongoing shutdown is beginning to strain essential safety-net services, with others at risk if it continues. Federal government payments for food stamps (CalFresh in California) are being delayed for the month of November, which means millions of people across the country will not receive food stamps. California has allocated \$80 million to support food banks and deployed the California National Guard to assist with food distribution. CalWORKs (California's Welfare program) payments will be distributed for November, but the state has warned that December benefits could be delayed if the shutdown continues.

As these challenges unfold locally, attention is also turning to the decisions California voters will face in the upcoming election on November 4. Proposition 50 would temporarily adjust California's congressional district maps in response to partisan redistricting efforts seen in several other states including Texas, Virginia and North Carolina. The outcome of Prop. 50 and efforts in other states could help shift control of Congress in the November 2026 elections. If that happens, a Democratic Congress could serve as a check on President Trump and his agenda. Locally, Santa Clara County voters will consider Measure A, a temporary 0.625% sales tax increase projected to generate roughly \$330 million annually; revenue that could help offset the impact of HR 1-related cuts and sustain vital county services. The outcomes of both will inform how we approach future policy and advocacy efforts.

Your leadership continues to guide our systems through uncertainty. Together, we will continue to meet each challenge with the same commitment and resolve that defines California's public health care systems.

Medicare Open Enrollment and Medi-Medi Plans

Medicare open enrollment runs from Oct. 15 through Dec. 7. During this period, eligible individuals can enroll in [Medi-Medi plans](#), which combine Medicare and Medi-Cal benefits under one coordinated plan.

Starting in 2026, Medi-Medi plans will be offered in 41 counties: nine new plans will launch,

Update on the Federal Government Shutdown

As we enter day 24 of the shutdown, the absence of bipartisan negotiations marks a noticeable departure from previous shutdowns. House Speaker Mike Johnson continues to claim the House will remain adjourned until the Senate can act on a government spending bill. In the Senate, the impasse deepened as Democrats blocked a Republican funding proposal to pay military personnel and government workers this week. The vote, which forced Democrats to oppose government worker compensation, underscored the widening gulf between the parties.

Despite this political gamesmanship, some Republican congressional representatives are beginning to recognize the political risks as their constituents face rising ACA premiums, the loss of SNAP and food assistance benefits, and mounting pressure from federal employee unions seeking to prevent federal layoffs.

In addition to the direct effects of the shutdown, several other major programs and policies have their authorizations tied to the federal government's spending bills.

CAPH continues its advocacy during this critical period and will keep members informed as the shutdown continues.

CMS Medicare Telehealth Updates

In anticipation of Congressional action to extend the Medicare telehealth flexibilities, the Centers for Medicare and Medicaid Services (CMS) is holding, rather than denying, claims for Medicare telehealth services provided after Oct. 1. CMS encourages providers who choose to continue providing telehealth services that may not be payable to consider issuing an [Advance Beneficiary Notice of Noncoverage](#) to patients.

CMS also released updated [frequently asked questions](#) indicating that federally qualified health centers can continue billing for non-behavioral telehealth services delivered through telecommunications technology by reporting HCPCS code G2025 on claims, consistent with a policy finalized in the [2025 Physician Fee Schedule](#).

It remains unclear whether a patient's home qualifies as an eligible location for these services. Because CMS is not classifying these services as "telehealth", the flexibility likely remains in place. CAPH continues gathering additional information about this policy and will share updates as they become available.
